1. Reference a establishes the requirement for a power line filter for on-line use of cryptographic equipment. Reference b approved the Siemens T37i CA one-time tape mixer for NATO use. Reference c approved the Siemens Tbk 176A Buffer Relay Unit for use with NATO on-line cryptographic equipment. Reference d sets forth additional requirements for on-line use of the T37i CA following a re-evaluation.

2. Ministry of Defense, Germany has now provided the required filters to be added to the Tbk 176A and SECAN has confirmed that this meets the conditions of reference d.

3. The T371 CA is hereby approved for on-line processing of NATO information of all classifications under the following conditions:

- a. The Tbk 176A with additional filter B84406-B20 must be installed on the signal line at least ten feet from the equipment.
- b. The equipment must be operated within a 200 foot secure zone.
- c. The provisions of reference a are applicable.
